1. Must have completed a reasonable amount of the acquired property inspections,
2. Complete all modules and units of this Housesafe Certification Course,
3. Complete the HEP and obtain an acceptable percentage (pass mark),
4. To hold appropriate PI & PL Insurances required for Industry Protection, (To provide Housesafe with a current PI and PL Certificate of Currency),
5. Have a current website showing their ability **www.....**,
6. Have an active email address**@.....**,
7. To **provide** Housesafe with **1 passport type and sized digital photo**, (known as a head shot) for the Housesafe "ID card",

CERTIFICATION ON COMPLETION OF THIS COURSE AND EXAMINATION YOU WILL RECEIVE:

1. A "Certificate of Completion" for every Certified HCPI,
2. A photographic Housesafe ID card (HIDC), 2 x 300mm Car Stickers and a 1 Polo Shirt, **(please provide shirt size, M, L, XL or XXL, please circle your Housesafe polo shirt size)**,
3. 1 CPD point is issued per hour (8 hour course = 8 CPD's) (Continuing Professional Development),
4. Be listed (for FREE) within the Housesafe's Certified Inspector section on the Housesafe website,





